## Camp Use Guidelines

- Upon arrival, the group leader must check in with Camp Ranger and provide a Group Roster.
- Vehicles are limited to the parking lot. Be prepared to carry all your gear to your campsite.
- Please observe the 5 MPH speed limit on camp roads.
- All fires must be kept in designated burn areas within the campsites and must be supervised at all times.
- ALL open flame fires must be at least 10 feet away from any structure. (This includes charcoal.)
- Fire equipment (shovel/rake/water) must be present, and the fire should be out cold at night and before leaving.
- ALL liquid fuel cans must be left and locked in vehicles. National policy on the use of liquid fuels must be followed.
- No timber, conifers, or brush are to be cut.
- No swimming/boating in any lake is allowed without following the BSA Safe Swim Defense and Safety Afloat.
- No UN-AUTHORIZED, including airsoft or pellet guns or personal shooting sport equipment, is allowed in camp.
- Each group must bring its own cooking equipment (campsites) and supplies. (Baker has a limited amount of equipment available for checkout at the Quartermaster Building.)
- No dishwashing at water taps.
- Please do not feed or harass the deer or any other wildlife.
- Groups should practice Leave No Trace camping.
- No pets are allowed in camp, including in the parking lot.
- Service animals are permitted. Please inform the council before your arrival if you will be bringing a service animal.
- Smoking/vaping is only allowed in the parking lot, out of the sight of youth.
- Please make reservations no less than 14 days in advance.
- All reservations and rates are subject to review, specifically for the intended use and intended corresponding rate.
- All units/groups are expected to clean up after themselves. The group leader must check out with the Ranger before leaving. A service fee will be charged if trash is not removed.
- Any damage to buildings or campsites (including the discharge of fire extinguishers) is the responsibility of the user and will be billed accordingly.



## **Camp Reservation Policy**

- All reservations must be made 14 days before your arrival or earlier.
- All cancellations must be submitted in writing.
- Cancellations 30 days or more before the reservation date will receive a full refund, minus a 15% administrative fee.
- Cancellations 29 to 15 days before the reservation date will receive a 50% refund.
- No refunds for cancellations that occur with less than 14 days' written notice.
- Exceptions to this policy can be granted for extreme circumstances at the discretion of the Scout Executive or their designee.
- A fully refundable deposit of \$25 (for campsites) or \$200 (for buildings or special program areas) is due at the time the reservation is made. Deposits will be refunded within 30 days after the final camping date, pending a "clean" Check-out report is received.
- Any remaining site fees are due 14 days before the event.
- Non-PCC groups must provide a Certificate of Liability Insurance naming Pacific Crest Council and The Boy Scouts of America as additional insured for the time they are using the camp. The certificate of insurance must be provided to the Pacific Crest Council office 14 days before the event. Please refer to the Insurance Requirements page found in this document.
- The Pacific Crest Council reserves the right to limit usage, either specifically or generally. (Examples include, but are not limited to, water slides, horses, group size, etc.)

**RELEASE AND WAIVER OF LIABILITY**

The individual named below, the organization/group named below, and each participating person in said organization/group (“We” or “us”) desire to enter and use the real property owned by **PACIFIC CREST COUNCIL, BSA** (“Owner”), known as **CAMP BAKER** located at **5262 Boy Scout Road, Florence, Or 97439** (“Property”). In consideration of being permitted by the Owner to enter and use the Property, and in recognition of the Owner's reliance hereon, I, for myself, as authorized agent of the organization/group, and as attorney-in-fact for each participating person in said organization/group agree to the following terms and conditions:

1. WE ARE AWARE AND UNDERSTAND THAT ACCESSING THE PROPERTY MAY INVOLVE THE RISK OF SERIOUS INJURY, DISABILITY, DEATH, AND/OR PROPERTY DAMAGE. WE ACKNOWLEDGE THAT ANY INJURIES THAT ANY OF US SUSTAIN MAY RESULT FROM OR BE COMPOUNDED BY THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF THE OWNER, INCLUDING NEGLIGENT EMERGENCY RESPONSE OR RESCUE OPERATIONS OF THE OWNER. NOTWITHSTANDING THE RISK, WE ACKNOWLEDGE THAT WE ARE VOLUNTARILY ACCESSING THE PROPERTY WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY, DISABILITY, DEATH, AND/OR PROPERTY DAMAGE ARISING THEREFROM, WHETHER CAUSED BY THE ORDINARY NEGLIGENCE OF THE OWNER OR ANY RELEASEE OR OTHERWISE.
2. We hereby expressly waive and release any and all claims, now or hereafter known, against the Owner, and their respective officers, directors, employees, agents, affiliates, successors, and assigns (collectively, “Releasees”), on account of injury, disability, death, or property damage arising out of or attributable to our being on or using the Property, whether arising out of the ordinary negligence of the Owner or any Releasees or otherwise. We covenant not to make or bring any such claim against the Owner or any other Releasee, and forever release and discharge the Owner and all other Releasees from liability under such claims.
3. We shall defend, indemnify, and hold harmless the Owner and all other Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including attorney fees, the costs of enforcing any right to indemnification hereunder, and the cost of pursuing any insurance providers, incurred by the Owner or any other Releasees arising out of or resulting from any claim of a third party related to our being on the Property.
4. We have read, understand, and agree to comply with those certain Rules, Terms & Conditions for Non-Scout Group Use of Scout Camps/Facilities that have been provided to us. We agree that we will follow all instructions of any onsite property manager or other representative or agent of the Owner while on the Property.
5. If any term or provision of this Release is invalid, illegal, or unenforceable, such invalidity, illegality, or unenforceability shall not affect any other term or provision herein.

**BY SIGNING, I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS RELEASE AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE BSA.**
